



# "MOXISFIVE" Invitation Code Promotion (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. Without limiting clause 2 of these terms, these terms must also be read together with the CX Registration Terms.
- 4. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 6. If you:
  - (a) during the Promotion Period, use an Invitation Code to open a Mox Account;
  - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process and receive a welcome notification from Mox (the day on which you receive the welcome notification, your "Joining Day"); and
  - (c) during the period beginning on and from your Joining Day and the following 30 days, complete the Mox Credit application process and receive a Mox

- 1. 本條款適用於 Mox Bank Limited (「Mox」或「我們」)進行的本推廣。 參與本推廣即表示您同意接受本條款。
- 2. 您必須一併閱讀本條款、Mox 的個人資料 收集聲明、私隱政策聲明、一般條款及細 則(包括其所有附表),其分別可於 Mox app 及/或我們的網站上找到及我們可能 向您提供的任何其他條款而該等條款將繼 續一併適用於您與我們的關係及您就我們 的產品及服務的使用。

Credit approval notification from Mox (the day on which you receive your approval notification, your "Approval Day"), subject to these terms, during the period beginning on and from your Approval Day and the following 60 days, you will receive Mox Card Rewards for the Spending Rewards Scheme you have chosen, as if you have an Eligible Balance for Card Rewards of HKD250,000 (even if you have an Eligible Balance for Card Rewards of less than HKD250,000); and

- (d) during the period beginning on and from your Joining Day and the following 60 days, spend at least HKD2,000 on one or more Eligible Transactions with, either your:
  - (i) Mox Card linked to your Mox Account ("Mox Account Spending Requirement"), subject to these terms, you will receive the Mox Account Spending Reward; or
  - (ii) Mox Credit Card ("Mox Credit Spending Requirement"), subject to these terms, you will receive the Mox Credit Spending Reward,

which we will deposit into your Mox Account upon settlement of the last Eligible Transaction that you have made to satisfy the Spending Requirement.

- 7. For the avoidance of doubt:

If you are eligible to receive Asia Miles pursuant to these terms, we will let AML know using your Membership Information, so that AML can deliver the Asia Miles to your Cathay Membership Account. We are not responsible for the delivery of any Asia Miles to your Cathay Membership Account and will not be liable for any failure or delay in the delivery of any Asia Miles (or any part thereof) to your Cathay Membership Account.
- 9. From time to time, we may require you to provide additional information in connection with your Cathay Membership Account to maintain its registration with Mox and/or to facilitate the delivery of any Asia Miles you may be eligible to receive under these terms. We will notify you of any such requirements from time to time.
- 10. It is your responsibility to ensure the accuracy and completeness of the information that you provide to us. If any information that you provide to us (including any Membership Information) is inaccurate and/or incomplete, we may not be able to register your Cathay Membership Account with us, you may not be eligible to receive any Asia Miles under these terms and/or the Asia Miles may not be delivered to your Cathay Membership Account.
- 11. You can only participate in the Promotion once. You can only receive one Spending Reward subject to clause 6(d) above. If you have an Eligible Balance for Card Rewards of HKD250,000 or more, you will not be entitled to any additional Mox Card

- 13. We will determine whether an Eligible Transaction has occurred based on transaction records held by us (which are final and conclusive in case of any discrepancy).
- 14. You will receive the reward, gift or any other benefit in respect of the Promotion, only if:

- (h) "Mox Credit Spending Requirement" has the meaning given in clause 6(d)(ii) of these terms.
- (i) "Mox Credit Spending Reward" means a cash reward of HKD1,000.
