



# "MOXTRIP25" Invitation Code Promotion (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 5. If you:
  - (a) during the Promotion Period, use the Invitation Code to open a Mox Account; and
  - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process and receive a welcome notification from Mox (the day on which you receive the welcome notification, your "Joining Day"),

subject to these terms, you will receive the Welcome Reward, which we will deposit into your Mox Account within 15 days after you satisfy all the requirements in this clause 5.

6. In addition to clause 5 of these terms, if you:

- 9. The use of the Invitation Code is subject to a quota of 1,200 uses. The 'Promotion Period' will end on the earlier of the last day of that period and the day on which the Invitation Code has been used 1,200 times. The use of the Invitation Code is on a first come, first served basis (as determined by us in our absolute discretion). We will not update you on the quota usage or its continued availability.
- 10. We will determine whether an Eligible Mox Credit Card Transaction has occurred based on transaction records held by us (which are final and conclusive in case of any discrepancy).
- 11. You will receive the reward, gift or any other benefit in respect of the Promotion, only if:
  - (a) you have not held a Mox Account in your name, at any time, in the 12 months prior to your Joining Day. You are considered to have held a Mox Account even if you haven't completed any transactions on your previous Mox Account;
  - (b) when we attempt to deliver the reward, gift or other benefit, you still have your Mox Account that you opened using the Invitation Code and Mox Credit that you opened pursuant to the Promotion and none of your accounts with Mox has been suspended or is in arrears or default; and

  - (b) suspend or terminate the Promotion or these terms;
  - (c) refuse to give you any reward, gift or other benefit in respect of the Promotion:
    - (i) if we believe any of your accounts with Mox have been opened for an improper purpose (for example, to secure multiple rewards, gifts or other benefits by closing and opening one or more Mox Accounts);
    - (ii) if we believe that any proceeds in any of your accounts with Mox are the proceeds of any illegal, fraudulent or abnormal activity; or
    - (iii) for any other reason we deem appropriate; and
  - (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion).

Any such decision shall be conclusive and binding on you.

13. Without limiting anything in these terms,

- 15. If any dispute arises in connection with the Promotion, our decision is final.
- 16. To the extent permitted by laws and regulations:
  - (a) neither Mox nor any of its affiliates, shareholders or partners shall be responsible for any loss or damage suffered by you; and
  - (b) you shall release Mox and its affiliates, shareholders and partners from all actions, proceedings and claims which may be brought against Mox or its affiliates, shareholders or partners,

- 19. The Promotion does not constitute any offer, invitation or recommendation to any person to enter into any transaction.
- 20. Neither your right to participate in the Promotion nor your eligibility to receive any reward, gift or other benefit in respect of the Promotion may be transferred or assigned to any other person or exchanged or converted into any other benefit or right.
- 21. Nothing under these terms or the Promotion will deem, imply or suggest that a person or entity is acting as our agent or

- 25. To borrow or not to borrow? Borrow only if you can repay!

#### 26. Definitions

- (b) "Eligible Mox Credit Card Transaction" means a transaction for the purchase of goods or services on the Trip.com platform, as determined by Mox (in its sole and absolute discretion) to be eligible to contribute towards the Spending Requirement. Without limiting the above:
  - (i) for a transaction to contribute towards the Spending Requirement, the transaction must have been settled by the merchant (i.e. appear as 'completed' in the Mox app) by the end of the period specified in clause 6(b) of these terms; and

- (e) "HKD Savings Account Balance" means, in respect of a calendar day, the Hong Kong denominated deposits held in all your savings accounts with Mox, excluding all 'cash on hold' in your Mox Invest Account originating from unsettled proceeds from the sale of Funds or Securities, as at 23:59:59 (Hong Kong time) on that calendar day.

For the avoidance of doubt, any deposits held in your Time Deposit Account(s) will not count towards your HKD Savings Account Balance.

(f) "Hold Fund Period" means the period beginning on and from the last day of the Fund-in Period and the following 59 calendar days (both days inclusive).

For example, if you opened your Mox Account on 21 July 2025, your Hold Fund Period is the period beginning on 28 July 2025 and ending on 25 September 2025 (both dates inclusive).

- (g) "Invitation Code" means 'MOXTRIP25'.
- (h) "**Joining Day**" has the meaning given in clause 5(b) of these terms.
- (i) "Promotion Period" means, subject to clause 9 of these terms, the period
